

Frequently Asked Questions On Paying A Tribute To MCA Veteran Members, 2012

- 1) ***What is the requirement for one to receive the MCA Thanksgiving Ang Pow?***
Anyone born in the year 1952 or before and they must be members in benefit prior to the decision made by the MCA Central Committee Meeting held on 21st November, 2011.
- 2) ***If a person attaining the age of 60 is not a MCA member, can he or she now apply to get the ang pow?***
Certainly, they can apply for MCA membership. However, what needs to be considered is whether we will have the same exercise in the year 2013.
- 3) ***An applicant who has already attained the age of 60, but still has not got his/her membership approved. Is he/she entitled to receive the ang pow?***
No.
- 4) ***How does one receive the ang pow?***
Any member who is qualified is required to complete a form by updating his/her personal particulars together with a photocopy of his/her Identity Card (both sides).
- 5) ***Does a member require to submit his/her recent coloured passport-sized photograph?***
Yes, if he/she wants to apply for a latest MCA Membership Card.
- 6) ***Can I download the updating form from the website?***
Yes. You can download the form from either the MCA official website at www.mca.org.my or MCA facebook at www.facebook.com/mcahq.
- 7) ***Who should be the witness as specified in the updating of membership form?***
 - The Chairman/Deputy Chairman/Secretary of the MCA Branch/Division/State concerned.
 - Member of Parliament or the State Assemblyman
 - The Coordinating Officer of the Constituency concerned
 - The Executive Secretary of the State/Division concerned
- 8) ***If one is qualified to receive the ang pow, when will it be given out? How will it be paid out?***
All applications to reach the MCA HQ on or before 31st December, 2011 and they will be paid the ang pow by the HQ via the Branch on or before 15th January, 2012 by cheque.
- 9) ***If the updating form would to reach the party HQ after 31st December, 2011, is it acceptable?***
Yes, it will still be accepted. However, to facilitate the administrative work of the HQ, it is advisable that one submits his/her updating form on or before 31st March, 2012.
- 10) ***How would the cheque be sent out if the Branch concerned is dormant?***
Under such a situation, the cheque will be issued to the qualified member via the Division.
